It was established a time limit from 2014 to 2019 of the publications in English, French or Spanish. Articles that addressed the projects objectives were included. Results: 18 articles were selected which main categories of analysis were: arguments of parents to doubt or refuse vaccination, how to be addressed by the nurses, their dismissal of unvaccinated children, and the individual right and mandatory vaccination.
