For the case from Antioquia the relative economic and politics stability of the one that enjoyed the State of Antioquia during the second half of the XIX century, added to "a predominant ethnic and cultural homogeneity of their society", it constituted a mark more than appropriate for the formation of one of the most solid political hegemonies in the country during the period.
