The ICJ has delivered a most important order on provisional measures in the case *Allegations of Genocide under the Convention on the Prevention and Punishment of the Crime of Genocide (Ukraine v. Russian Federation)*. Its relevance stems not only from the context, but also the language used by the Court, certain statements it made with regard to Russia's actions in Ukraine, and the measures ordered. Nevertheless, the outcome does not dispel the doubts arising from the Ukrainian application relating to the Court's jurisdiction *ratione materiae*. This work analyses this question based on the arguments presented so far before the Court and reaches the conclusion that, indeed, Ukraine cannot find a clear basis for its requests, in either the text of the Genocide Convention, or the protection of its object and purpose
