A chronological journey through the different historical periods will be made, considering the facts of the time, and contextualizing the theories of each of the thinkers mentioned here, influenced by the circumstances contemporary to their development. Finally, the solutions to corruption that were sought since ancient times are analyzed, many of them like those imposed today - with the only exception of the temporal distance and its correlative adaptation. In some cases, some of the proposals devised centuries ago were more genuine than those tried today.
