The article will seek to reflect on the state approach to social conflicts in the province of Jujuy, based on the study of a case that will allow us to analyze some of the local ways in which the exercise of state power has manifested itself, in times of COVID-19 Pandemic. In March 2021, in the Campo Verde neighborhood of San Salvador de Jujuy, a series of acts of state violence took place against neighborhood protests in defense of a public space. The "Campo Verde" case will be studied by investigating how the State and the different state bureaucratic agencies intervened in the conflict, at the same time it will be analyzed what was the neighborhood response to state actions. Special consideration will be given to inter-American standards on the exercise of the right to social protest, as well as to the State's human rights obligations that should guide institutional responses to such conflicts. From the study carried out, a process of infra-criminalization of the state agents who starred in the repressive acts and of over-criminalization of the neighbors who participated in the protest on whom criminal and contraventional cases were initiated was evidenced.
