

## Court Case, Advertisement, and Letters Connected to Manhole Bar, Chicago /

A five-page package of documents contains informations related to a lawsuit by a patron of a Chicago bar, who claims he was beaten by a bouncer and others on Nov. 11, 2001. It includes: his complaint and claim for \$50,000, with notes on the incident written in purple; and ad from his lawyer, seeking co-plaintiffs; a letter to the Illinois Liquor Control Commission, asking that the bar's license be revoked; and a letter to the city fire commissioner, asking that he investigate alleged repeated code violations
